Compliance Features

The ASC app allows users to document the entire communication and archive recordings in compliance with the respective legal regulations such as MiFID II, HIPPA or Dodd-Frank. Typical requirements like recording control (the ability to flexibly start/stop recordings), individual access rights, and TTL as well as sophisticated encryption mechanisms are met and can be adjusted according to the customers' needs. A visual and/or acoustic notification informs users about the recording of the call (recording notification).

Encrypted data exchange is possible between ASC Recording Insights and neo systems at any time. Recordings can be transferred to both systems. Individual export and import options can be defined according to the customers' requirements.

Cognitive Services

Users can transcribe, translate, and analyze audio and video data by means of Microsoft Cognitive Services. Communication content can thus be classified, extracted, transcribed, tagged, translated, and analyzed without the need for human review. Potential compliance risks can be identified proactively in real time.

Data Security

To comply with applicable security standards, customers have the option to choose the geographic region where their data is stored in the Microsoft Azure Cloud. With over 60 regions in 140 different countries, Azure offers comprehensive options to ensure compliance and resilience.
